MEMORANDUM OF ASSOCIATION

OF  
20 MICRONS LIMITED

- I. The name of the Company is 20 MICRONS LIMITED.
- II. The Registered Office of the Company will be situated in the State of Gujarat.
- III. The objects for which the Company is established are :

**(A) THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:**

- 1. To purchase, take on lease or otherwise acquire mining works, mining grounds, mining rights, mines, ponds, plots of land in India or elsewhere, believed to contain various types of minerals whether natural or otherwise.
- 2. To pulverise, refine, classify, calcine, coat various chemicals, minerals either singly or in combination for its use by any industry.
- 3. To manufacture, produce, upgrade, mix, extract, convert, pulverise, refine, process, import, export, buy, sell, and to act as wholesalers, retailers, commission agents, brokers, distributors, factors and dealers in all types of minerals whether natural, synthetic or otherwise either in lump, slurry, powder form or in any other form.
- 4. to carry on business of manufacturers, producers, refiners, processors, importers, exporters, wholesalers, retailers, commission agents, brokers, distributors, factors and dealers in all types of plastics and its raw materials like plasticisers, lubricants, stabilisers and waxes.
- 5. To carry on business as manufacturers, buyers, sellers, importers, exporters and dealers in any and all kinds of paints, pigments, varnishes dye-stuff, and all kinds of products and by-products arising there from or in connection therewith and all implements, materials and things incidental to, or useful in connection with, any such business.
- 6. To carry on the business as manufacturers, buyers, sellers, distributors, agents, stockists, refiners, importers and exporters of and dealers in detergents, washing powders and soaps.
- 7. To carry on business of manufacturers of and dealers in papers and its raw materials.
- 8. To carry on business, either on its own account or on account of constituents of buyers, sellers, importers and exporters of and dealers in cements, silica, building materials.

**(B) OBJECTS INCIDENTAL OR ANCILLAARY TO THE ATTINMENT OF THE MAIN OBJECTS:**

- 1. To become member of other bodies of persons and associations, including societies, clubs and companies limited by guarantee, whether formed for profit or for non-profit activities.
- 2. To apply for, purchase or acquire, protest and renew any patents, patents rights, copyrights, trademarks, formula Licenses, Concessions, any secret or information as to, any invention which may seem capable of being used for any of the purposes of the company or the acquisition of which may seem beneficial to the company and to use, exercise or develop or grant licenses in information so acquired.
- 3. To invest in real and personal property and rights of all kinds, and in particular lands, buildings, hereditament, business concerns and undertakings, including any interest in real or personal property.
- 4. To finance and promote industries and to lend and advance money to entrepreneurs, to give guarantee for payment of money or performance of any obligation or undertaking.
- 5. To pay out of the funds of the Company all the costs, charges and expenses of and incidental to the promotion, formation, registration and establishment of the Company or any other company promoted by the Company or any company in which the Company is or may contemplate being interested.

6. To acquire and take over as a going concern by purchase of, on lease and to undertake, to carry on the whole or any part of the business together with the goodwill and trade-name, property, rights and liabilities of any person or persons, firm or any company carrying on business, which is within the objects of the Company and to pay for the same by shares, debentures, debenture stock, bonds cash or otherwise and to conduct and carry on or liquidate and wind up any such business.
7. To enter into Partnership or into arrangement for sharing profit or losses or for any union of interest joint ventures, reciprocal pre concession or co-operation with any person or persons or company or companies carrying on or engaged in or about to carry on or engage in or being authorized to carry on or engage in or in any business or transaction capable of being conducted so as directly or indirectly to benefit this Company.
8. To amalgamate, enter into foreign or Indian, technical and /or financial collaboration, partnership or into any arrangement for sharing of profits, union of interest, co-operation, joint venture, reciprocal concession or otherwise with any person, firm, corporation or Government or company carrying on, engaged in or about to carry on or engage in business, undertaking or transaction which the company is authorized to carry on or engage in and to take or otherwise acquire and hold share or securities of any such persons, firms or companies and to sell, hold, re-issue with or without guarantee with the same.
9. The Company may at any time invite and receive or without any such invitation receive any gifts of immovable or movable property and offerings or voluntary donations or bequests and legacies either from the shareholders or from any other person or give gifts of immovable or movable property and offerings or voluntary donations, bequests and legacies either to the shareholders or to any other person for all or any of the objects of the Company with or without any special conditions provided such gifts received of gifts made or the conditions attached are not inconsistent with or derogatory to any of the objects of the Company.
10. To place to reserve or to distribute as bonus, shares the moneys arising from the sale by the Company of forfeited shares in conformity with the provisions of the Companies Act, 1956.
11. To promote, form and to be interested in, and take, hold and dispose of shares in any other company having objects similar, altogether or in part to those of this Company or carrying on any business capable of being conducted so as directly or indirectly to benefit the Company and to subsidise or assist any such company financially or otherwise by issuing or subscribing for or guaranteeing the subscription and issue of shares, stocks, debenture-stock, or other securities of such company and to transfer to any such company any property of this Company and to take others or otherwise acquire, hold and dispose of shares, debentures and other securities in or of any such company.
12. To enter into, make and perform contracts and arrangements of every kind and description with corporate body, State or Central Government or any companies, firms or persons that may seem conducive to the Company's objectives or any of them and to obtain from any such authority any rights, privileges, charters, contracts, concessions, licenses for manufacture, purchase and sale of any kind of goods, machinery, spare parts, securities, shares, stocks, debentures, which the Company for the time being may think desirable to obtain and to carry out, exercise and comply with such arrangements, rights, privileges and concessions.
13. To sell, sub-let, mortgage, lease, manage, develop, exchange, dispose of, or transfer the business, immovable or movable property and undertaking of the Company or any part thereof or any part of the property, rights and concessions of the Company in such manner and upon such terms and conditions and for such consideration as the Directors of the Company, for the time being may think fit to accept and in particular for cash, shares, debentures, debenture-stock, bonds or securities of any other company having objects altogether or in part similar to those of this Company.
14. Subject to the provisions of Section 58A of the Companies Act, 1956 and Rules there under and directives of Reserve Bank of India, to receive, raise or borrow money from time to time for any of the purpose of the Company by bonds, debentures promissory notes or by taking credit, in or opening current accounts with any individual or firm or with any Bank or bankers and whether with or without giving any security, goods or other articles or by mortgaging, charging, hypothecating any lands, buildings and machinery, goods, assets or revenue of the Company, present or future including its uncalled capital or by the issue of debentures, debenture-stock, perpetual or otherwise including debentures or debenture-stock, convertible into shares of this or any other company or to convey the same absolutely or in trust and give lenders power of sale and other powers as may be expedient and to purchase redeem or pay off such securities.
15. To lend or deposit moneys belonging or entrusted to or at the disposal of the Company to such person or company and in particular to customers and others having dealings with the Company with or without security upon such terms as may be thought proper and to invest or otherwise employ

such moneys in such manner as may be thought proper and from time to time to vary such transactions. However, the Company shall not carry on banking business as defined under the Banking Regulation Act, 1949.

16. To invest and deal with the moneys of the Company not immediately required in immovable properties, shares, stocks bonds, debentures, obligations or other securities of any company or association or in Government securities or in current or deposit account with Banks or on the mortgage of immovable properties of any tenure or on the pledge of movable property or in any other manner as may from time to time determined by the Directors of the Company for the time being and from time to time, sell or vary all such investments and execute all assignments transfers receipts and documents that may be necessary in the behalf.
17. To give guarantee for the performance or discharge of any obligations, liabilities, duties or the payments of moneys by any persons, firms and companies or Governments of States and to give indemnities.
18. To assist any company financially or otherwise, or by issuing or guaranteeing the subscription and issue of capital, shares, stock, debentures, debenture-stock or other securities and to hold and deal in shares, stocks and securities of any company notwithstanding there may be liability thereon.
19. Subject to the provisions of the Act, to distribute among the members in specie or kind any property of the Company or any proceeds of sale or disposal of any property of the Company, in the event of winding up.
20. To draw, make, issue, accept, transfer and endorse, discount, execute and negotiate promissory notes, hundies, bills of exchange, cheques, drafts, bills of lading, letters of credit, delivery orders, dock-warrants, railway or transport receipts, warehouse-keeper's certificate and other negotiable or commercial or mercantile instruments connected with the business of the Company.
21. To open accounts with any Bank or Banks and to deposit moneys therein and to draw and endorse cheques on and to withdraw moneys from such accounts and generally operate upon same (whether overdraft or not) as may be required for any of the objects or purposes of the Company.
22. To insure any of the persons, properties, undertakings, contracts, guarantee or obligations or profits of the company of every nature and kind in any manner whatsoever.
23. To refer any dispute, claim or demand by or against the Company to arbitration and observe and perform the awards.
24. To establish provide, maintain and conduct or otherwise subsidise research laboratories and experimental stations, workshops for scientific and technical researches, experiments and tests of all kinds and to promote studies and research both scientific and technical investigations and invention by providing, subsidising, endowing or assisting laboratories, workshops, libraries, training, colleges, schools and other institutions for training, lectures, meeting and conferences and by providing the remunerations of scientific or technical professors, or teachers and by providing for the award of exhibitions, scholarships, prizes and grants.
25. To be interested in, promote and undertake the formation and establishment of such institutions, associations, chamber of commerce, or other bodies, business, industrial, trading or manufacturing within the objects of the Company and to acquire, promote and/or subsidise any industry or undertaking.
26. To undertake and execute any trust the undertake whereof may seem desirable either gratuitously or otherwise, and/or to make donations to any persons, company or association and to subscribe or guarantee money for any national, international, charitable, benevolent, educational, public, object, activity exhibition of trade show which may be conducive to the objects to the Company or in the interest of its members or for the welfare of the staff and generally to encourage, promote and reward studies, researches, investigations, experiments, tests and inventions.
27. To enter into any arrangements and to take all necessary or proper steps with Governments or with other authorities, supreme, national, local municipal or otherwise of any place in which the Company may have interest and to carry on any negotiations or operations for the purpose of directly carrying out the objects of the Company or effecting any modification in the constitution of the Company or furthering the interest of its members and to oppose any such steps taken by the other company, firm or persons, which may be considered likely to prejudice the interests of the Company or its members and to promote or assist the promotion, whether directly or indirectly of any legislation which may appear to be in the interest of the Company and to oppose and resist legislation which may seem disadvantageous to the Company and to obtain from any such Government authority or any company any charter, contracts, decrees, rights, agents, loans, privileges, or concessions which the Company may think fit or desirable to obtain to carry out exercise and comply with any such arrangements, charters, contracts, decrees, rights, privileges, or concessions.

28. To promote, form and register and aid in promotion, formation and registration of any company or companies subsidiary or otherwise for the purpose of acquiring all or any of the property, undertaking, rights and liabilities of such company and to be interested in, or take or otherwise acquire, purchase, hold, sell or otherwise dispose of shares, debentures and other securities in or of any such company, or any other company for all or any of the objects mentioned in this Memorandum and to subsidise or otherwise assist any such company.
29. To create any depreciation fund, reserve fund, sinking fund, insurance fund, dividend equalising fund, capital redemption fund or any other special fund whether for depreciation, or for repairing, improving, extending or maintaining any of the property of the Company or for redemption of debentures or redeemable preference shares, or for any other purpose whatsoever conducive to the interest of the Company.
30. To provide for the welfare of the Directors, ex-Directors, employees or ex-employees of the Company or its predecessor in business and the wives and families of the dependents or connections of such persons by building or contributing to the building of houses, dwellings, chawls, or quarters or by grants of money, pensions, gratuities, allowances, bonuses, awards, profits sharing or other scheme or trust any by providing or subscribing or contributing, towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance and other assistance as the Company shall think fit and to establish, maintain and grant scholarships, monies to any persons for technical study and education in India and elsewhere in the world which may be necessary or useful for any of the objects of the Company, and to subscribe or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national or other institutions or objects which shall have any moral or other claim to support or and by the Company either by reason of locality of operation or of public and general utility or otherwise.
31. To pay out of the funds of the Company, all expenses of and incidental to the issue of subscription of the shares or loans or capital including brokerage, underwriting or other commission for obtaining applications for or placing or guaranteeing the placing of shares or any debentures, debenture-stock and other securities of this Company and also all expenses attending the issue of any circular or notices and printing, stamping, circulating, proxies and forms to be filled up by the members of the Company.
32. To employ experts to investigate and examine into the conditions, prospects, value, character and circumstances of any business, concerns and undertakings and generally of any assets, concessions, properties or rights.
33. To donate or gift in cash or kind, for any national, charitable, benevolent, public or useful purposes or to any institution, club, society, research association, fund, university, college or any other person or body.
34. To apply for, secure, acquire by grant, legislative, enactment, assignment, transfer, purchase or otherwise, and to exercise, carry out, enjoy and charter, license, power, authority, franchise, concession, right or privilege, which any Government or authority or any corporation or other public body may be empowered to grant, and to pay for, aid in, and contribute towards carrying on the same into effect.
35. To apply for, purchase or otherwise acquire any patents, patent rights, copyrights, trade marks formulae, licenses, concessions and the like or any secret or other information, the acquisition of which may seem calculated directly or indirectly to benefit the Company.
36. To adopt such means of making known the business of the Company as may seem expedient and in particular, by advertising in the press or any other means, by circulars, by purchase and exhibition of works of art or interest, by publication of books and periodicals and by granting prizes, rewards and donations.
37. To manufacture, buy, sell, exchange, fabricate, assemble, finish, refine, repair, alter, improve, convert, manipulate, prepare for market, import, export, let on hire and otherwise deal in all kinds of plants, machinery and equipments such as gasifires, oil engines, diesel engines, kerosene engines, petrol engines, hand and industrial blowers of all description and sizes, mining machines, grinding machines, milling machines, drilling, boring and tapping machines, lathe machines, gear cutting and gear grinding machines, tools for metal cutting and metal working, hammers and forging machines, welding machines and equipments, welding electrodes, press sheet metal shaping machines and equipments, wire working and converting machines, weighing machines and weights, printing machines, cutting machines, wood working machines, sewing machine, apparatus, utensils, receptacles, substances, ingredients and components, materials, articles and things and machine tools of all types, sizes and description necessary or convenient for carrying on the business or

process of the Company and things capable of being used in connection with any business of the Company.

**(C) OTHER OBJECTS NOT INCLUDED IN (A) AND (B) ABOVE ARE :**

1. To carry on all or any of the business of prospecting, exploring opening and working, mines, drill and sink shafts or any well and to pump, refine, raise, dig and quarry for oil, petroleum, gold, silver, diamonds, precious stones, coal, earth, limestone, iron, aluminum, titanium, vanadium, mica, apalite, chrome, copper, gypsum, lead, manganese, molybdenum, nickel, platinum, uranium, ruthenium, sulphur, tin, zinc, zircon, bauxite, tungsten and other ores and minerals.
2. To carry on business as spinners, weaves, hem stitches, platters, knitters, embroiderers, tailors, dress makers, costumers, clothing manufacturers, carpets and sport goods, manufacturers gloves, hatters, dyers, cleaners, washers, textile bleachers, printers, drapers, brace and belt makers, goods, manufacturers and general curfitters and manufacturers and dealers in synthetic and man-made fibers and yarns.
3. To carry on all or any of the businesses of manufacturers of and dealers in all types of rubber, leather, plastic, lattes, celluloid, Bakelite and similar goods and their accessories and fittings, including tyres, tubes, rolls, rollers, shoes and packaging items.
4. To carry on all or any of the businesses of manufacturers of and dealers in cement lime, plasters, ceramic, sanitary fittings, asbestos, sheets, chinaware, whitening clay, gravel sand, mineral earth, coke, fuel and stone and builders requisites and conveniences of all kinds.
5. To carry on all or any of the businesses of goldsmiths, silversmiths, jewelers, gem and diamond merchants and of manufacturing and dealing in jewellery, cutlery and their components and accessories and of producing, acquiring and trading in metals, bullions, gold ornaments, silver utensils, diamonds, precious stones, paintings, coins, manuscripts, curious antiques and objects of art.
6. Subject to the provisions of Law to carry on all or any of the business of brewers, distillers, millers, bakers, butchers, confectioners and makers and manufacturers of and dealers in flour, rawa, maida, biscuits, bread, sugar, gur, khandsari, syrups, food articles of all types and descriptions.
7. To make use of all such powders produced naturally or synthetically for production of various items viz. adhesives, caulks, putties, primers, paints, polishes, and similar other materials.
8. To carry on the business of processing, canning and cold storage of fruits, vegetables, seeds, fish, meat, agricultural products, milk and dairy products and other perishable items.
9. To carry on all or any of the businesses of printers, stationers, lithographers, type founders, stereotypers, electrotypers, photographic printers, photo lithographers, chrome-lithographers, photographers, engravers, die-sinkers, book binders, advertisement agents.
10. To undertake and carry on any of the traders or businesses of shippers, ship owners, ship brokers, ship repairers, shipping agents, dry dockers and ship managers, tug owners, loading brokers, freight contractors, carriers by land, water, transport and general contractors, barge owners; lighter men railways and forwarding agents, dock owners, engineers, ice merchants, refrigerators, store-keepers, stevedores, warehousemen, wharfingers, ship repairers and dealers in machinery, engines, nautical instruments and ship rigging gear fitting and equipments of every description, generally to carry on the said business either in principals or agents on commission or otherwise.
11. To carry on the business as manufacturers of and dealers in radio sets, television sets, radio receiving and transmitting sets, transistors, tape recorders, cassette tapes, toys, educational aids, video, video tapes and their accessories, components parts, air conditions, wireless apparatus and machinery, appliances and radio and other materials, goods, machinery and requisites.
12. To carry on the business of acting as advisers and consultants on all matters and problems, relating to finance, investments, portfolio management, to resident as well as non-resident Indians.
13. To establish, bird, fish, animal and wild life sanctuaries, zoological parks, horticultural gardens and carry on the business of breeding of horses, animals, fish and to conduct the business of racing.
14. To carry on the business and trade as travel, tourist agents and contractors and to conduct and manage tours or voyages by rail, road, sea or air of tourists and passengers for facilities to book passages and arrange for reservation and ticket, to provide all kinds of conveniences or facilities during travels, tour journeys, voyages and flights.
15. To cultivate, maintain or deal in cereals, seeds, nuts, fruits, vegetables, dairy and garden produce milk, cream, butter, cheese, eggs, poultry, fish, meat, foodstuffs, and provisions.



16. To carry on the business as sole or general agents or general representatives and sole or general stockists or distributors, organizers or commission agents of any industrial, commercial or agricultural enterprise.
17. To carry on the business of acting as advisers and consultants on all matters and problems relating to engineering, administration, finance, organization, management, personnel, commencement and expansion of industries, techniques, production, storage, purchase, sales, marketing, distribution, advertising, publicity material, cost and the rendering of engineering services to individuals, firms, bodies corporate, institutions, associations, and department of the Government.
18. To carry on the business of manufacturing, marketing, servicing and leasing computers, word processors and other microprocessors bases systems as well as the manufacturers of software programme for use with any of the above mentioned items.
19. To carry on the business of film manufacturers, film apparent manufacturers, film producers, both sound and silent, hippodrome and circus proprietors, managers and cinema houses, theatres, concert halls, picture places and studios. To carry on the business of letting or subletting to use of cinema halls, theatres, picture places, studios or other machinery, apparatus, building or structure of the Company for purposes or use, execution, display of films, dramatic or theatrical performances, concerts or other entertainments or amusements or objects allied to or of similar kind as of the Company and provide for the production, direction, exhibition, representation, display whether by mechanical means or otherwise of plays, open-air, or other theatrical performances, operas, vaudevilles, ballets, pantomimes, juggling, mesmeric, yogic hypnotic, spectacular.
20. To carry on the business of running polyclinics, nursing homes, clinics, dispensaries, maternity homes, child welfare and family planning centers, diagnostic centers, pathological laboratories, X-Ray clinics and also to carry on the business of running crèches.
21. To carry on the business as manufacturers assemblers, buyers, sellers or otherwise dealers in all types of automobiles, motor cars, lorries, two wheelers and three wheelers including their components spare parts and accessories.
22. To carry on the business of hire purchase, finance of leasing of all durable, industrial and commercial properties, assets, vehicles, machinery, equipments, tools and instruments of all descriptions, refrigerators, air-conditioners washing machines and household equipments, television and electronic devices.
23. To carry on the business of investment company and to buy, sell, underwrite, invest in, acquire, hold and deal in shares, stocks, debentures units, debenture-stock, bonds, obligations and securities issued or guaranteed by any company constituted or carrying on business in India or elsewhere and debentures, debenture-stock, bonds, obligations and securities issued or guaranteed by any Government, State, dominions, sovereign rules, commissioners, public body or authority, supreme, municipal local or other body, firm or person whether in India or elsewhere and also to invest in, buy and sell bullion, precious metal, precious stones, real estate, whether in India or elsewhere.
24. To manufacture, buy, sell, import, export or otherwise deal in all types of office automation equipments such as typewriters, calculators, cash registers, telecommunication equipments also to manufacture and deal in writing and drawing instruments, pollution control and safety equipments.
25. To manufacture, buy, sell, import, export, act as consultants and otherwise deal in all types of packaging materials such as, cartons, plain and corrugated boxes, cones, cups, plates, napkins, jars, straw, wrappers, bags, foils, receptacles, composite containers, straps, paper board, straw board all types of boards, aid papers, molded plastics, pvc, acrylic sheets, polyethylene poly propylene, polyurethane, polyester, polystyrene and any other packing materials and also to undertake turnkey project for packing industry.
26. To carry on the business of imports, exports, wholesale, commission agency, storage, distributorship, handling, shipping forwarding agency, representation, liaison and agency or special agency, factors, bailees, brokerage in such commodities goods or lines and on such terms and conditions as the Company from time to time decide upon, to take up agencies of any or all manufacturers of India and abroad and to act as their representatives, agents, distributors throughout India and other foreign countries, and to buy, sell, take or let on hire, import, export manipulate, treat, prepare for market and deal in merchandise, commodities and articles of all kinds.
27.
